Nominations for the Top Tech Exec Awards were open to all businesses and IT executives in San Diego County, with submissions delivered through the <u>Top Tech Exec</u> <u>website</u>. An independent panel composed of experienced business executives and information technology professionals reviewed the nominations and selected the qualified nominees to be further evaluated by the Top Tech Exec Awards judges.

Now 20 years in business and with assets under administration (AUA) at nearly \$30 billion, CFS/SPF oversee the service and support of hundreds of investment programs at financial institutions around the country.
